COMMENTS: The files were in overall good order and properly maintained. There were a few deficiencies identified during the review, see below. Based on conversation with Management, two of the issues noted below (assets and Health and Safety forms) appear to be due to miscommunication during a third-party management change. The two items were clarified prior to the end of the onsite visit.

- Income: Unit 5100D needs to be calculated per employment verification form to capture the higher income amount per company practice. The corrected amount did not affect the household's eligibility. Management is advised to update the income on the Initial Income Certification form. The corrected form was submitted to TSAHC prior to issuance of this report.
- Assets: Unit 200AA had a bank account statement in the tenant file that listed cash deposits. Asset clarifications were submitted to TSAHC prior to the issuance of this report. The clarification sheet explained that the tenant was cashing her paychecks and submitting them as cash deposits to her count.
- Health and Safety Forms: The required from was missing in the tenant file for units 218DB, 225AB, 5100D, 5100D, and 5200C. The missing forms were submitted to TSAHC prior to the issuance of this report.
