- Unit 38: The tenant files did not have a copy of the Social Security Award Letter. Management verified this amount using HUD approved verification method (i.e., EIV). Management submitted clarification of the overlook and requested the award letter. The social security award amounts were accurate and therefore no further action is necessary.
