Prior to the completion of this report management corrected the assets that were entered incorrectly on the Tenant Income Certification (TIC) for unit 16 and adjusted the effective date on the recertification TIC for unit 9. In addition, prior the submission of the report, management added the income totals in item "L" on the TIC that were initially forgotten. Management is aware to be careful not to make these minor mistakes and when possible, have a peer or supervisor review the files when they are ready.
