COMMENTS: The tenant files were in a neat and organized manner. Management and the compliance team appears to be doing a superb job reviewing applicants and recerts. There were three minor discrepancies noted during the tenant file review. Units 1607 and 1902 had assets that were incorrectly labeled or calculated. In addition, the income needed to be moved to a different column on the TIC for unit 1101. None of the income or asset adjustments affected program eligibility. Prior to the issuance of this report, the discrepancies noted above were corrected.
